Release and waiver of liability. Assumption of Risk and indemnity and parental Consent Agreement.

In consideration of being permitted to participate in any way in

CAPC Taking Steps sponsored walking activity, I, for myself, my personal representatives, assigns, heirs and next of kin:

• ACKNOWLEDGE, agree and represent that I understand the nature of CAPC Taking Steps and that I am qualified, in good health and in proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.

• Fully understand that (a) running, walking can involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death (risks), (b) these risks and dangers may be caused by my own actions and inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place or the negligence of the "Releasers" named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND RESPONSIBILITY FOR SUCH LOSSES, COSTS AND DAMAGES I incur as a result of my participation in the activity.

• HEREBY RELEASE, DISCHARGE AND COVENANT NOT TO SUE CAPC OR WESTCHESTER COUNTY, their respective administrators, directors, agents, officers, members, volunteers and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors or premises on which the activity takes place (each considered one of the "Releasers" herein) from all liability, claims, demands, losses or damage on my account caused or alleged to be caused whole or in part by the negligence of the "Releasers" or otherwise, including negligent rescue operations; and further I agree that if, despite this release and waiver of liability, assumption of risk and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the "Releasers," I will indemnify, save and hold harmless each of the "Releasers" from any litigation expenses, attorney fees, loss liability damage or cost that any may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, fully understand its terms, understand that I have GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

IF PARTICIPANT IS UNDER 18, I, the parent and/or legal guardian of said minor child, understand the nature of running and walking activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue and agree to indemnify, save and hold harmless each of the "Releasers" from all liability, claims, demands, losses or damages on the minor's account caused or alleged to be caused in whole or in part by the negligence of the "Releasers" or otherwise, including negligent rescue operations and further agree that if, despite this release, I, the minor or anyone on the minor's behalf makes a claim against any of the "Releasers" named above, I will indemnify, save and hold harmless each of the "Releasers" from any litigation, expenses, attorney fees, loss liability, damages, or any cost that may incur as the result of any such claim.
